

## TERMS AND CONDITIONS OF THE CONTEST

### "G2A Plus Week – Collect Coins & Win"

#### 1. GENERAL PROVISIONS

1.1. These Terms and Conditions (hereinafter referred to as the **"Terms and Conditions"**) define the rules of a contest conducted in the form of a digital, skill-based online game under the name **"Plus Week – Collect Coins & Win"** (hereinafter referred to as the **"Contest"**).

1.2. The promoter of the Contest is G2A.COM Limited, with its registered office in Hong Kong, address: 31/F, Tower Two, Times Square, 1 Matheson Street, Causeway Bay, Hong Kong, Business Registration Number: 63264201 (hereinafter referred to as the **"Promoter"**).

1.3. The Promoter is the operator of the platform available at [www.g2a.com](http://www.g2a.com) (hereinafter referred to as the **"G2A.COM Platform"**).

1.4. The Contest is conducted globally via the G2A.COM Platform on a dedicated G2A Plus landing page available at: <https://www.g2a.com/plus> (hereinafter referred to as the **"Landing Page"**).

1.5. The Contest takes place during Plus Week, i.e. from **June 18, 2026 at 08:00 (UTC)** until **June 25, 2026 at 07:59 (UTC)** (hereinafter referred to as the **"Contest Period"**).

1.6. The Contest is divided into **seven (7) separate daily rounds**, each lasting 24 hours (each a **"Daily Round"**).

1.7. Participation in the Contest is voluntary. By clicking the **"PLAY"** button, the Participant confirms that they have read, understood and accepted these Terms and Conditions and agree to comply with them.

1.8. The Contest constitutes a skill-based competition. The outcome depends solely on the Participant's speed, attention and skills. The Contest does not constitute a lottery, gambling or game of chance within the meaning of applicable laws.

1.9. The Contest is also conducted in accordance with the G2A.COM Platform Regulations available at: <https://www.g2a.com/terms-and-conditions> (**"G2A.COM Platform Regulations"**), in particular Section 5.7 [G2A PLUS] related to the G2A PLUS loyalty program (**"G2A Plus"**).

#### 2. DEFINITIONS

For the purposes of these Terms and Conditions, the following definitions shall apply:

**Account** – a user account on the G2A.COM Platform, created in accordance with the G2A.COM Platform Regulations.

**User** – a person who has created an Account on the G2A.COM Platform.

**Participant** – a User who meets the eligibility criteria set out in Section 3 of this Terms and Conditions and participates in the Contest.

**G2A Plus Premium** – a paid subscription tier of the G2A Plus loyalty program.

**Coins Game** – the Contest task, which is a digital, skill-based online game consisting of finding and clicking six (6) digital “Coins” placed on predefined pages of the G2A.COM Platform in the shortest possible time.

**Game Start** – the moment the Participant clicks the “PLAY” button on the Landing Page.

**Game End** – the moment the Participant clicks the sixth (6th) Coin.

**Digital Game Key** – a digital, single-use activation key for a video game, distributed electronically.

**Plus Points** – loyalty points granted within the G2A Plus program in accordance with its applicable rules, in particular G2A.COM Platform Regulations, Section 5.7. [G2A Plus].

### 3. PARTICIPATION CONDITIONS

3.1. The Contest is intended exclusively to Users who, at the moment of starting a given Daily Round:

- a) have an active Account on the G2A.COM Platform; and
- b) are logged into their Account; and
- c) are active G2A Plus Premium users, including existing G2A Plus Premium users or Users who join G2A Plus Premium during the Contest Period;
- d) accept and comply with these Terms and Conditions.

3.2. Users who are not logged in or who do not have an active G2A Plus Premium subscription will not be able to participate in the Contest.

### 4. CONTEST RULES

#### 4.1. Contest Task

4.1.1. The objective of the Contest task is to find and click six (6) Coins placed on consecutive, predefined webpages of the G2A.COM Platform in the shortest possible time.

4.1.2. Coins must be clicked by the Participant in the correct order, from Coin #1 to Coin #6.

4.1.3. Each webpage contains only one (1) Coin.

4.1.4. The Participant is directed through a predefined sequence of pages determined by the Promoter and is not required to independently or randomly search for Coins across the G2A.COM Platform.

#### 4.2. Time Measurement

4.2.1. Time measurement of the Coin Game starts at the moment of clicking the “PLAY” button and ends when the Participant clicks the sixth (6th) Coin.

4.2.2. Leaving the Coin Game, navigating to other pages or returning to the Landing Page does not stop or reset the timer of the Coin Game.

4.2.3. The condition for successful completion of the Coin Game is clicking all six (6) Coins in the correct order.

#### 4.3. Daily Rounds and attempts

4.3.1. Each Daily Round starts at **08:00 (UTC)** and ends at **07:59 (UTC)** the following day.

4.3.2. Each Participant may participate **only once (1 time) per Daily Round**.

4.3.3. During the Contest Period, a Participant may play **a maximum of seven (7) times**, i.e. once per Daily Round.

#### 4.5. Participants' prohibited actions

4.5.1. Participants are strictly prohibited from using any tools, applications, software, scripts, bots, automation mechanisms or other technical means that could interfere with the proper conduct of the Contest, affect the measurement of time, manipulate the ranking, or otherwise provide an unfair advantage or enable circumvention of the Contest rules.

4.5.2. Participants are prohibited from engaging in any actions that aim to circumvent or bypass the rules of the Contest, including but not limited to allowing third parties to perform the Coins Game on their behalf, sharing access to their Account, or using any methods that result in the Coins Game being completed in a manner not directly and personally performed by the Participant.

### 5. RANKING AND WINNER SELECTION

5.1. For each Daily Round, the Promoter shall create a **daily ranking** based on:

- a) the shortest Coin Game completion time;
- b) in the event of identical Coin Game completion times, the earlier timestamp of Game End prevails.

5.2. **Top ten (10) Participants** with the best results of Coin Game in each Daily Round shall be declared winners. The Promoter shall verify and announce the winners.

5.3. Prize allocation per Daily Round:

- **places 1-3** – Digital Game Keys;
- **places 4-10** – Plus Points.

5.4. A Participant may win a **Digital Game Key only once during the entire Contest Period**.

5.5. A Participant may win **Plus Points multiple times**, including on consecutive days.

### 6. PRIZES

#### 6.1. Prize Pool

6.1.1. During the entire Contest Period, a total of **seventy (70) prizes** shall be awarded.

6.1.2. The prize pool consists of:

**6.2. General Prize Rules**

6.2.1. All prizes are digital, delivered electronically, and do not require physical shipment.

6.2.2. Prizes cannot be exchanged for cash, other prizes or their monetary equivalent.

6.2.3. Digital Game Keys are single-use activation codes.

6.2.4. Plus Points are credited to the Account of the Participant who wins and is eligible to receive such points, in accordance with the G2A Plus program rules.

6.2.5. The Promoter reserves the right to replace a prize with another prize of equal or higher value if delivery of a specific prize becomes impossible for reasons beyond the Promoter's control.

## **7. WINNER NOTIFICATION AND PRIZE DELIVERY**

7.1. Winners shall be notified by e-mail sent to the e-mail address associated with their Account.

7.2. Notification shall be sent within up to four (4) days from the end of the relevant Daily Round.

7.3. By participating in the Contest, the Participant consents to receiving e-mail communication related to the Contest results and prize delivery.

## **8. DISQUALIFICATION**

8.1. The Promoter reserves the right to exclude a Participant from the Contest if the Participant:

- a) violates these Terms and Conditions; and/or
- b) violates G2A.COM Platform Regulations; and/or
- c) attempts to manipulate the ranking, time measurement or technical mechanisms of the Coin Game; and/or
- d) uses automated tools, scripts or bots; and/or
- e) acts in breach of applicable law.

## **9. COMPLAINTS**

9.1. Complaints regarding the Contest may be submitted:

- a) in writing to the Promoter's registered office address; or
- b) by e-mail to: [support@g2a.com](mailto:support@g2a.com).

9.2. A complaint should include:

- subject of the e-mail (if complaint is submitted by the e-mail) "COMPLAINT - Contest G2A Plus Week - Collect Coins & Win"
- the e-mail address associated with the Account;
- a description of the issue;
- the specific request.

9.3. Complaints shall be processed within 14 days from the date of receipt.

## **10. PERSONAL DATA PROTECTION**

10.1. The Promoter is the controller of the Participants' personal data.

10.2. Personal data shall be processed for the purposes of:

- conducting the Contest;
- creating rankings and awarding prizes;
- contacting winners;
- handling complaints;

- compliance with applicable laws.

## 11. FINAL PROVISIONS

11.1. These Terms and Conditions are available on the Landing Page throughout the Contest Period.

11.2. For important reasons, the Promoter reserves the right to amend these Terms and Conditions, without prejudice to rights already acquired by Participants. Important reasons shall include in particular:

- a) a change in the law that has a direct impact on the content of the Terms and Conditions or the conduct of the Contest;
- b) introducing new or changing existing functionalities of the G2A.COM Platform;
- c) prevention of abuse or infringement;
- d) a change in the way the Contest is conducted due to technical or technological reasons;
- e) a change in the way services are provided due solely to technical or technological reasons;
- f) change of the scope or provision of services to which the provisions of the Terms and Conditions apply, by introducing new, modifying or withdrawing by the Promoter the existing functionalities or services covered by the Terms and Conditions;
- g) circumstances beyond the Promoter's reasonable control, including force majeure.

Any amendment to the Terms and Conditions shall be published on the Landing Page in a manner that allows Participants to become acquainted with its content. Amendments shall become effective from the moment of their publication, unless stated otherwise.

11.3. In matters not regulated herein, the G2A.COM Platform Regulations and applicable law shall apply.
